John Martin Moye, please pray for Juan Martin Garcia executed Tuesday, October 5, 2015

Mr. Juan Martin Garcia doesn't know our Blessed Founder John Martin Moye, but let's use this "moment of Providence" to ask Blessed Father Moye to intercede for Mr. Garcia on Tuesday the day of Garcia's scheduled day of execution...his last day of life on this earth, our common home.

Juan Martin Garcia is 35 years old and had been on Texas' Death Row for 15 years. His violent crime of murder involved three co-defendants, a .25 caliber pistol, and a personal robbery that yielded him \$8.00. This is the 131st public prayer vigil of ours is held at the Wayside Cross on 24th Street in front of OLL Convent.

OCTOBER 14, 2015

Thirty-six year old Licho Escamillo was executed by the State of Texas on October 14, 2015 at 6:00 pm in Huntsville, Texas. Mr. Escamillo completed the 8th grade and was 19 years old when he violently took a life using a gun.

Five weeks since Texas' last execution

Mr. Raphael Deon Holiday, 36 years old with a 9th grade education, was executed at 6:00 pm by the State of Texas on November 18, 2015 in Huntsville. The three minor victims (ages 7, 5, and 1) were his step-children and his own child. Please pray for Raphael Holiday, the victims, and all parents who struggle with anger and violence toward their children.

TWO MONTHS Without a Texas Execution!

RICHARD MASTERSON was executed tomorrow, January 19, 2016 ,at 6:00 pm in Huntsville, TX. The last Texas execution by lethal injection was November 18th, 2015. Mr. Masterson was 42 years old and had a 6th grade education. When he was 28 he took another man's life by strangulation.

Last Texas Execution was 7 days ago

On January 27, 2016, 35 year old James Freeman was executed by the State of Texas at 6:00 pm in Huntsville, Texas. Twelve years ago Mr. Freeman murdered (using an assault weapon) a 34 year old

game warden. This is the 135th such prayer vigil we have had since September of 2008 when we began. The State of Texas is doing both of these killings in your name.

February 17, 2016

We don't know! Mr. Gustavo Garcia, 44 years old, was executed by the State of Texas (in YOUR name) on Tuesday, February 17, 2016 at 6 pm in Huntsville, TX. When he was 18 years old he committed a shotgun slaying of a convenience store clerk during a robbery. He has been on death row since he was 19. Hopefully, he has been touched and has repented over these 25 years on death row and has received God's mercy, forgiveness, and love. The Sisters of Divine Providence pray to "accompany" Mr. Garcia on his journey from earth into the loving arms of his/our Provident God.

March 9, 2016

Is there a connection? Guns, lack of education, execution? Coy Westbrook is scheduled to be executed by the State of Texas on Wednesday, March 9 at 6 pm in Huntsville, Texas. He is 58 years old. Westbrook went through life with only an 8th grade education. At age 39 he shot four people to death (people that he knew) with a .36-caliber hunting rifle. Please pray to our merciful God for him, his victims, their families and friends, his family and friends, for all who turn to violence to solve their problems, and AN END TO THE VIOLENT DEATH PENALTY especially in Texas.
